Rainier Agility Team will cover economy airfare, shuttle to the airport, airport parking, course copies, and meals on the day(s) of travel. We require receipts for all expenses and will provide you with a reimbursement form, or you may download it from our website www.ratagility.com. For airfare, you can present us with a bill at the trial, or, if you prefer, we can reimburse you ahead of time; just email us a copy of your receipt. We pay \$1.00 per run and take care of your food and lodging. A rental car may be provided if the trial site is over 50 miles from SeaTac airport. This is at the Trial Chair's discretion and must be an economy vehicle used by both judges. RAT does not pay for kenneling fees.
